## **UN Convention – Committee of Experts Elected**

Article 34 of the Convention on the Rights of Persons with Disabilities provides for the establishment of a Committee on the Rights of Persons with Disabilities, consisting of twelve experts of high moral standing and recognized competence and experience in the field covered by the Convention. The first Conference of States Parties on the Convention on the Rights of Persons with Disabilities (CRPD) elected the new Committee on the Rights of Persons with Disabilities which will be in charge of monitoring the implementation of the CRPD. The Committee comprises seven men and five women, of which nine are persons with disabilities. The election took place on 3 November 2008.

## **Non-Discrimination Legislation Debated at EU Committee**

We already told you in previous newsletters that on 2 July 2008, the EU Commission adopted a proposal for a directive which provides for protection from discrimination on grounds of age, disability, sexual orientation and religion or belief beyond the workplace. This new directive would ensure equal treatment in the areas of social protection, including social security and health care, education and access to and supply of goods and services which are commercially available to the public, including housing.

Report from EDF (European Disability Forum):

On 5 November, the European Parliament Employment Committee discussed the Directive at its meeting. At that meeting, Ms Lynne (ALDE Group) stressed the importance of the future legislation for providing equal protection for all in Europe and paid tribute to Commissioner Spidla for his courage in proposing the Directive.

Members of the Socialist Group of the European Parliament supported the draft report of Ms Lynne and announced that they intended to propose a number of amendments to further strengthen it. The draft report was also supported by representatives of GUE, UEN and Green Political Groups. The speaker representing the EPP-ED Group expressed the view that the legislation is not the right way to fight against discrimination in Europe. However, she said, should there be legislation, it should not overburden businesses and propose feasible rules, with no extra red-tape.
